For the purpose of section 18 of the Children's Free and Compulsory Education Act, 2009, the certificate of recognition for a school under sub-rule (4) of rule 11 of the Children's Free and Compulsory Education Rules, 2011.

Dear Sir/Madam,

References to the application letter received from you and subsequent correspondence with the school in I. Guru Gobind Singh Public School Hardobathwala, Gurdaspur-2 District Gurdaspur for class I to class VIII Punjab Government School Education Department (Education-3 Branch) No.SED-EDU301/114/2023-3EDU3/645126/2023 Dated Chandigarh Dated 19-09-2023 hereby issue a permanent recognition from 01-04-2024 until further orders.

This approval will be considered valid only after the fulfillment of the above conditions.

Terms:

1. The period of approval for accreditation cannot be extended and in no case is there any commitment for accreditation/affiliation beyond class VIII.
2. The school will strictly comply with the Right of Children to Free and Compulsory Education Act 2009 (Annexure 1) and the Right of Children to Free and Compulsory Education Rules 2011 (Annexure 2).
3. The school will provide free and compulsory education up to the completion of elementary education to all students from weaker sections and disadvantaged sections in their neighbourhood, up to 25% of the class, including the first grade. This rule will also apply to pre-primary grades.
4. The school shall make provision as per sub-section 2 of section 12 of the Act for the students mentioned in paragraph no. 3 and shall provide a separate bank account for the purpose.
5. The school will not collect any compulsory fees from any parent or guardian for any action.
6. The school will not deny admission to any child for lack of proof of birth and will comply with the provisions of Section 15 of the Act.
7. The school will ensure:-
 - (a) No admitted student can be detained or expelled in any category until his elementary education is completed.
 - (b) No student will be subjected to physical or mental punishment.
 - (c) No student will be required to pass any board examination before completing elementary education.
 - (d) According to Rule 21, every student after receiving elementary education Certificate will be provided.
 - (e) Students with disabilities, incompetence or special needs will be admitted under the law.
 - (f) The teacher appointed under sub-section (1) of section 23 shall have fulfilled his educational qualifications. If already appointed, he shall have fulfilled his requisite qualifications. Minimum Educational Qualifications 5 years of employment from the date of implementation of the law they will complete the work in time.
 - (g) Teachers shall perform their duties under the rules prescribed under Section 24 and Sub-section (1) of the Education Act.
 - (h) Teachers shall not involve themselves in any kind of private tuition.

8. The school will follow the timetable and curriculum distribution regulated by the competent administrative body/authorities.
9. The school will admit children as per the ratio specified in Section 19 of the Act.
10. The school shall comply with the criteria as per Section 19 of the Right to Education Act. The facilities which have been indicated as per the previous inspection, if any, are as under 20 (As per the report)
 - Area of the school (as per report)
 - Total built up area as per report)
 - Area of sports ground as per report)
 - Number of classrooms as per report)
 - Headmaster cum officer cum storage room (as per report)
 - Availability of reading and writing materials/sports equipment/library materials.
11. No unrecognized class will be taught inside or outside the school premises under the name of the same school.
12. The school building and structure or playground shall be used solely and exclusively for the educational activities and skill development of the school.
13. A school (Act No. 21 of 1860) operated or operated by any public body for some time, as a registered society.
14. The school should not be run to benefit any individual class or individual coalition.
15. The school accounts should be audited by a certified accountant/CA and the accounts should be prepared as per the rules. Every year, a copy of the accounts will be sent to the District Education Officer (DEO) for information.
16. The permanent recognized identification number of your school is 006. Please note this and do not quote this identification number while dealing with correspondence in future.
17. The school shall submit all such reports and information to the District Education Officer or the Director of Education Department from time to time and shall be bound to furnish such information to the State Government or the local authority as may be directed by them from time to time.
18. It should be ensured that the registration of the organization has been renewed.
19. If the school violates the RTE Act 2009 and the Right of Children to Education and Compulsory Education Rules 2011 in the future, then the school's recognition will be cancelled in those cases.
20. Other conditions are attached as per the Annexure.

Note:- This recognition is issued on the condition that the school will ensure to obtain Building Safety Certificate, Fire Safety Certificate and Water Purity Certificate from the concerned department every year as per the period.
